Mt. Helix Pest & Termite Control has been contracted to provide pest control service to your association. Please report pest problems to your Management Company or Mt. Helix Pest Control directly. If you would like to schedule an interior pest control service, please contact our office at 619-584-6794. Please call our office to find out your regular service day. We recommend calling into our office at least 2 weeks before the regular service, just in case a change has been made due to holidays in the month. Target pests we treat for are Ants, Roaches, Fleas, Crickets, Wasps, Bees, Silverfish and other general crawling insects.

STATE LAW REQUIRES THAT YOU BE GIVEN THE FOLLOWING INFORMATION: **CAUTION PESTICIDES ARE TOXIC CHEMICALS.** STRUCTURAL PEST CONTROL COMPANIES ARE REGULATED BY THE STRUCTURAL PEST CONTROL BOARD, AND APPLY PESTICIDES WHICH ARE APPROVED FOR USE BY THE CALIFORNIA DEPARTMENT OF FOOD AND AGRICULTURE AND THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY. REGISTRATION IS GRANTED WHEN THE STATE FINDS THAT BASED ON EXISTING SCIENTIFIC EVIDENCE THERE ARE NO APPRECIABLE RISK IF PROPER USE CONDITIONS ARE FOLLOWED OR THAT THE RISKS ARE OUTWEIGHED BY THE BENEFITS. THE DEGREE OF RISK DEPENDS ON THE DEGREE OF EXPOSURE, SO EXPOSURE SHOULD BE MINIMIZED.

IF WITHIN 24 HOURS OF APPLICATION YOU EXPERIENCE SYMPTOMS SIMILAR TO COMMON SEASONAL ILLNESS COMPARABLE TO THE FLU, HEADACHE, DIZZINESS, NAUSEA CONTACT YOUR PHYSICIAN OR POISON CONTROL CENTER (SEE BELOW) AND YOUR PEST CONTROL OPERATOR IMMEDIATELY.
